

She was an Adjunct Professor at NYU's Tisch School of the Arts Graduate Film and TV, where she taught entertainment law and business to third year graduate students. She is an author of general non-fiction books, including legal works. Marilyn is a graduate of the New York University School of Law where she taught as an adjunct professor, and she is a member of the Bars of New York State, the District of Columbia and the US Supreme Court.
