

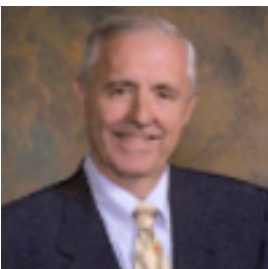

Because he is considered the authority on Michigan auto accident cases, Steve frequently lectures at legal seminars on topics such as trial advocacy, Michigan no fault law, traumatic brain injury cases and maximizing settlements for those injured in serious car and truck accidents. Steve is a graduate of the University of Michigan and Fordham University School of Law.
